Assignor agrees that, upon the request of Assignee, it shall, at its own expense, execute and deliver any and all instruments, documents or papers, make all rightful oaths, testify on behalf of Assignee, and do all other lawful acts necessary or helpful to carry out the intent of this Assignment and fully secure to Assignee the Trademark assigned under this Assignment and any rights therein.

This Assignment shall be binding on the parties, their successors, and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.
