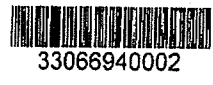

**ARTICLES OF MERGER
OF
INTRA CORP.,
INTO
WEBSTER VETERINARY SUPPLY, INC.,**

Pursuant to the provisions of the Minnesota Business Corporation Act, the undersigned corporations adopt the following articles of merger:

FIRST: The plan of merger is as follows:

- 1. The names of the parent and the subsidiary corporations are as follows:

Parent: WEBSTER VETERINARY SUPPLY, INC., a Minnesota corporation
Subsidiary: INTRA CORP., an Ohio corporation

- 2. The manner and basis of converting the shares of the subsidiary corporation into shares, obligations or other securities of the surviving corporation or any other corporation or into cash or other property in whole or part is as follows:

Each share of the Subsidiary Corporation shall be cancelled and the holder of the Subsidiary Corporation stock shall thereafter cease to have any rights with respect to such shares.

- 3. The Merger shall be effective upon the later of (i) the filing of the Articles of Merger with the Secretary of State of Ohio and the Secretary of State of Minnesota or (ii) April 24, 2009.

SECOND: The plan has been approved by the parent corporation in this parent-subsubsidiary merger pursuant to Section 302A.621 of the Minnesota Statutes.


THIRD: The number of outstanding shares of each class of the Subsidiary Corporation and the number of such shares of each class owned by the Surviving Corporation are as follows:


