## TRADEMARK ASSIGNMENT

This trademark assignment ("Assignment"), is from DIAMINTANGIBLES INTERNATIONAL, LTD., a company operating under the laws of the Commonwealth of the Bahamas, having offices at British Colonial Center of Commerce, One Bay Street, 3rd Floor, Nassau, Bahamas ("Assignor"), to SBRE LLC, a Limited Liability Company under the laws of the state of Delaware, having offices at 579 Fifth Avenue, New York, New York 10017 ("Assignee").

WHEREAS, Leo Schachter Diamonds, L.L.C., a New York limited liability company ("LSD"), and Kama-Schachter Jewelry, Inc., a Delaware Corporation ("KAMA"), jointly created, funded and developed the concept and trademark LOVE'S EMBRACE to be used for a line of diamond jewelry products, and intended to produce and sell such jewelry under said trademark; and

WHEREAS LSD and KAMA requested that Assignor (i) apply to register in the United States, Canada and Mexico and all territories and possessions of any of them (the "Territory") the trademark LOVE'S EMBRACE in both stylized and unstylized formats, either alone or in combination with other words, names symbols or devices, including, without limitation, LOVE'S EMBRACE - SURROUNDED BY THE STRENGTH OF YOUR LOVE and Design (collectively, the "Love's Embrace Marks"), (ii) temporarily hold title to the Love's Embrace Marks in the Territory and (iii) allow or license LSD and KAMA to commercially exploit the LOVE'S EMBRACE Marks, but only until such time as a bankruptcy remote entity owned indirectly by LSD and Kama should be formed to own said trademarks at which such time upon the joint direction of and on behalf of LSD and Kama Assignor was to assign said trademarks to such bankruptcy remote entity; and

WHEREAS Assignor has filed the applications listed in the attached Schedule A on the dates set forth therein for registration of the Love's Embrace Marks in the Territory in connection with jewelry and/or related products (the "Applications"); and

WHEREAS, Assignor is the sole owner, within the Territory, of the Love's Embrace Marks; and

WHEREAS Assignee is a bankruptcy remote entity owned entirely by SBRE Holdings LLC, which, in turn, is owned jointly by LSD and KAMA; and

WHEREAS, Assignee desires to acquire the Love's Embrace Marks and the Applications, together with the goodwill of the business appertaining thereto;

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, upon the joint direction of and on behalf of LSD and Kama, Assignor does hereby sell, assign and transfer to Assignee its entire right, title and interest in and to the Love's Embrace Trademarks and the Applications in the Territory, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, forever, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

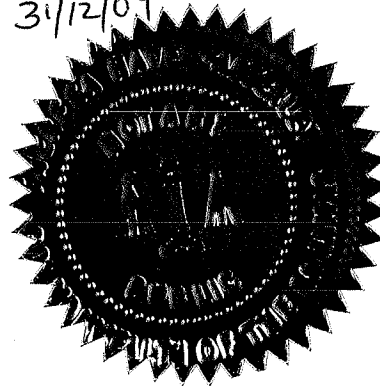
