RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("Release") is made and entered into as of the 2nd day of October, 2009 by and between NS Finance LLC, an Ohio limited liability company having a mailing address of 2200 Overlook Road, Cleveland, Ohio 44106 ("NS") and Emerald Innovations, LLC an Ohio limited liability company ("Emerald").

WHEREAS The Provident Bank, an Ohio banking corporation, formerly having an office at 1111 Superior Avenue, Cleveland, Ohio 44114 ("Provident") obtained in a Patent and Trademark Security Agreement ("Security Agreement") dated February 28, 2002 a security interest in each of the patents listed in Exhibit A and in each of the trademarks listed in Exhibit B (collectively, the "Security Interests") by a grant thereof from Emerald, the Security Agreement being recorded at the U.S. Patent and Trademark Office on July 15, 2002 at Reel/Frame 013077/0206.

WHEREAS National City Bank ("NCB") having a principal place of business in Cleveland, Ohio was the successor in interest to the Security Agreement and Security Interests by merger of Provident into NCB, the merger being evidenced by the Certificate of Merger attached as Exhibit C filed with the Secretary of State of Ohio on March 16, 2005.

WHEREAS NCB and NS entered into an agreement for the Assignment of Loan and Security Agreement and Related Documents ("Assignment of Loan") on September 1, 2009 wherein NCB granted, assigned and transferred to NS all of NCB's right, title and interest in, to and under that certain Loan and Security Agreement ("Loan Agreement") dated as of February 28, 2002, as amended, executed by Emerald, and Provident (now known as NCB), and all security instruments executed in connection therewith in accordance with, pursuant to and upon the terms and conditions of that certain Loan Sale Agreement executed by and between NCB and NS.

WHEREAS on or about October 1, 2009, NCB assigned, transferred, and conveyed to NS, its successors, assigns, and legal representatives any and all of NCB's rights, title, and interest in and to the Security Interests, including without limitation any and all of NCB's rights, title, and interest in and to the Security Interests arising after February 28, 2002.

WHEREAS Emerald is desirous of entering into a business arrangement with Dyno Seasonal Solutions, LLC, a Delaware limited liability company having a place of business at 1571 W. Copans Road, Suite 105, Pompano Beach, FL 33064 ("DSS"), the business arrangement including an assignment of a set of patents and trademarks listed in Exhibit D (the "Patent and Trademark Set").

WHEREAS Emerald now requests that NS release and terminate any Security Interests it has in the Patent and Trademark Set (collectively, "Special Security Interests").

NOW, THEREFORE, in consideration of the promises and mutual covenants contained in this Release and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, NS and Emerald hereby agree as follows:


1. Release. NS hereby releases and terminates its Special Security Interests, and hereby assigns, conveys, grants, sets over, transfers and releases to Emerald all rights title and interest NS may have, if any, in and to the Patent and Trademark Set.


