**CONFIRMATORY ASSIGNMENT OF TRADEMARK**

WHEREAS, Green Canyon LLC, a Delaware limited liability company having an address of 1209 Orange Street, Wilmington, Delaware 19801, used in its business the following trademark set forth in Schedule A attached hereto and assigned such mark and the goodwill associated with the mark effective December 27, 2007;

WHEREAS, Green Canyon LLC was dissolved by resolution of its sole owner and member effective December, 27, 2007, whereupon a Certificate of Cancellation was filed with the Delaware Secretary of State on that same date;


WHEREAS, CDI Corporation, a Pennsylvania corporation having an address of 1717 Arch Street, 35<sup>th</sup> Floor, Philadelphia, Pennsylvania 19103, acquired all right, title and interest in and to the said trademark together with the goodwill of the business symbolized by the trademark registration thereof as set forth in the attached Schedule A effective December 27, 2007 as the sole owner and member of Green Canyon LLC at the time of Green Canyon LLC's dissolution;

WHEREAS, under Delaware law, as a result of the dissolution of Green Canyon LLC, CDI Corporation succeeded to all of the assets and liabilities of Green Canyon LLC and therefore acquired all right, title and interest in and to the trademark set forth in Schedule A attached hereto, together with the goodwill of the business symbolized by the trademark and the registration thereof;

WHEREAS, it is desired that the assignment and transfer by operation of law of said registration be made of record in the United States Patent and Trademark Office.

NOW THEREFORE, for the sum of Ten dollars (\$10) and other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, said CDI Corporation (on behalf of the former Green Canyon LLC) hereby confirms the assignment and transfer by operation of law from Green Canyon LLC to said CDI Corporation of all right, title and interest in and to the said trademark set forth in the attached Schedule A, together with the goodwill of the business symbolized by the said mark, and the registration thereof effective from December 27, 2007.
