**TRADEMARK ASSIGNMENT**

TRADEMARK ASSIGNMENT ("Assignment"), dated as of March 10, 2009, by and among Alveolus, Inc., a North Carolina corporation having a principal place of business at 9013 Perimeter Woods Drive, Suite A, Charlotte, NC 28216 ("Assignor"), and Merit Medical Systems, Inc., a Utah corporation, ("Assignee," and collectively the "Parties"). NOW, THEREFORE, in view of the promises herein and in consideration of the sum of One Dollar (\$1.00) and other valuable and legally sufficient consideration, the receipt of which is hereby acknowledged by Assignor, Assignor does hereby sell, convey, transfer and assign and deliver unto Assignee, its successors and assigns, the entire right, title and interest in and to the Trademarks and further assigns to said Assignee all of the goodwill associated with and symbolized by the trademarks, including but not limited to the registered trademarks and trademark applications, including all common law rights associated with the trademarks by virtue of its use in commerce, and in and to any and all renewals thereof; and further assigns to said Assignee the priority right provided by the International Convention, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignee.

IN WITNESS WHEREOF, Assignor has caused this Assignment to be executed by a duly authorized officer of Alveolus, Inc.



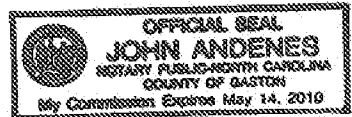
