ASSIGNMENT OF TRADEMARKS AND GOODWILL

This Assignment (“Assignment”) is made effective as of the 15 day of October, 2009, by and between:

Pappas Telecasting Companies (“PTC” or the “Assignor”), a corporation duly organized and existing under the laws of the State of Nevada, with offices at 500 South Chinowth Road, Visalia, California 93277

and

KPTM (TV) License, LLC (the “Assignee”) a Delaware limited liability company with offices at 4625 Farnam Street, Omaha, NE 68132.

WHEREAS, Assignor is the sole and exclusive owner of all right, title and interest in and to the trademarks and trademark registrations and trademark applications listed and/or described on Appendix A attached hereto (“Appendix A”) and made a part hereof (the “Marks”), and all common law rights to the Marks and all of the goodwill associated with the Marks; and

WHEREAS, Assignor is party to a certain Operational Separation and Settlement Agreement dated as of October 7, 2009, pursuant to which the Assignor has agreed to assign the Marks to the Assignee;

NOW THEREFORE, for the sum of One Dollar (\$1.00) per Mark, for a total of Three Dollars (\$3.00) as three (3) Marks are being transferred by this Assignment as evidenced by the three (3) Marks enumerated on Appendix A attached hereto, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, grant and convey to Assignee, its successors and assigns all of its right, title and interest, including common law rights, in the Marks, and all issued registrations with respect to same, as well as the goodwill related to the Marks and the right to sue and recover for all past, present and future infringement or other violation of the Marks, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made. Assignor hereby covenants and agrees to provide any further necessary documentation and do all further acts reasonably requested by Assignee in this regard to confirm and perfect title in and to the Marks in Assignee, its successors, assigns or other legal representatives, so long as the Assignee pays for all associated filing fees, costs and expenses.
