ASSIGNMENT OF TRADEMARKS AND GOODWILL

This Assignment ("Assignment") is made effective as of the 15 day of October, 2009, by and between:

NOW THEREFORE, for the sum of One Dollar (\$1.00) per Mark, for a total of One Dollar (\$1.00) as one (1) Mark is being transferred by this Assignment as evidenced by the one (1) Mark enumerated herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, grant and convey to Assignee, its successors and assigns all of its right, title and interest, including common law rights, in the Mark, and all issued registrations with respect to same, as well as the goodwill related to the Mark and the right to sue and recover for all past, present and future infringement or other violation of the Mark, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had this assignment not been made. Assignor hereby covenants and agrees to provide any further necessary documentation and do all further acts reasonably requested by Assignee in this regard to confirm and perfect title in and to the Mark in Assignee, its successors, assigns or other legal representatives, so long as the Assignee pays for all associated filing fees, costs and expenses.
