

Assignor hereby covenants and agrees to provide any further necessary documentation and do all further acts reasonably requested by Assignee in this regard to confirm and perfect title in and to the Mark in Assignee, its successors, assigns or other legal representatives, so long as the Assignee pays for all associated filing fees, costs and expenses.
