NOW, THEREFORE, in consideration of the sum of Ten U.S. Dollars (\$10.00) and other good and valuable consideration, the receipt, sufficiency and reasonably equivalent value of which are hereby mutually acknowledged, Assignor has, and by these presents does hereby irrevocably sell, assign, transfer and convey unto Assignee, its successors and assigns, all right, title and interest of Assignor in and to: (a) the Mark; (b) the Registration and any and all other issued federal or state trademark or service mark registrations of the Mark which Assignor may own; (c) any and all pending federal and state applications to register the Mark; (d) all common law rights in, to and under the Mark; (e) all other rights in, to and under the Mark, together with and including all goodwill of the business symbolized by the Mark; (f) any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Mark, and/or the goodwill under the Mark; and (g) all claims or causes of action Assignor has or may have in connection with the Mark including, but not limited to, the right to sue and recover damages for any and all past infringements of the Mark.

Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
