## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of the 20<sup>th</sup> day of October, 2009, by SUNTRUST BANK, in its capacity as Administrative Agent under the Credit Agreement referenced below (in such capacity, "Agent"), in favor of EasyLink Services International Corporation ("Grantor").

WHEREAS, in connection with that certain Revolving Credit and Term Loan Agreement, dated as of May 19, 2009, by and among the Grantor, the Agent, and the Lenders party thereto (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), Grantor, certain affiliates of Grantor, and Agent entered into a Security Agreement dated as of May 19, 2009 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") for the purpose of securing certain obligations of Grantor and certain of its affiliates to Agent;

WHEREAS, pursuant to the Security Agreement, Grantor granted the Agent a security interest in, among other things, the trademark listed on Exhibit A attached hereto (the "Trademark"), and pledged and mortgaged (but did not transfer title to) the Trademark to Agent; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark in accordance with the Credit Agreement and the Security Agreement, and the Agent has agreed to such request.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Credit Agreement and the Security Agreement:

The Agent hereby terminates and releases its security interest in the Trademark, and the Agent hereby assigns and transfers to Grantor, without any representation, warranty or recourse whatsoever, the Agent's entire right, title and interest in and to the Trademark, effective as of the date set forth above.

Agent hereby agrees to execute such further instruments and documents and perform such further acts as Grantor may deem necessary to convey to Grantor the rights herein conveyed.
