**ARTICLES OF ORGANIZATION OF

THIRD. The purposes for which the Company is formed are to transact any or all lawful business for which limited liability companies may be organized under the Act.

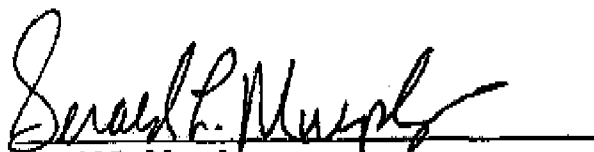
