TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of this 13th day of October, 2009, ("Effective Date"), by and between Lang Holdings, Inc., a Delaware corporation, Avalanche Publishing Acquisition, Inc., a Delaware corporation, The Lang Companies, LLC, a Delaware limited liability company, Avalanche Publishing, Inc., a California corporation (collectively, the "Assignors" and each, individually, an "Assignor") and LHI Enterprises, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignors and Assignee are parties to that certain Asset Purchase Agreement dated as of August 19, 2009, as amended, pursuant to which Assignors have agreed to sell, and Assignee has agreed to purchase, certain assets of Assignors;

WHEREAS, Assignors are the sole and exclusive owner of the entire right, title and interest in and to the United States trademark registrations and trademark applications, individual State registrations and foreign trademark registrations and trademark applications set forth on Schedule A attached hereto, together with all goodwill associated with any of the foregoing (collectively, the "Marks"); and

WHEREAS, Assignee wishes to acquire from Assignors, and Assignors wish to assign to Assignee, the entire right, title and interest in and to the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby sell, assign, transfer and set over to Assignee, the entire right, title and interest in and to the Marks, for the United States, individual States and all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States, individual States or any foreign country, now or hereafter in effect, together with all goodwill associated with any of the foregoing, and together with all income, royalties or payments accrued, due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same, in each case, for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made.

Assignors hereby request the Commissioner of Patents and Trademarks, and the corresponding entities, agencies or offices in any applicable individual States and foreign countries, to record Assignee as the assignee and owner of the Marks.

Assignors shall take all further actions and provide to Assignee, its successors, assigns and other legal representatives, all such cooperation and assistance at Assignee's request (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney and other documentation) to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to: (i) the preparation and prosecution of any application for registration,

or any application for renewal of a registration, relating to any of the rights assigned herein; (ii) the prosecution or defense of any interference, opposition, infringement, dilution or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the rights assigned herein and this Assignment; (iii) obtaining any additional trademark protection relating to rights assigned herein that may be secured under the laws now or hereafter in effect in the United States, any individual States or in any other country; and (iv) the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world.


