**SECURITY INTEREST ASSIGNMENT**

THIS SECURITY INTEREST ASSIGNMENT ("*Assignment*") dated as of **SEPTEMBER 25, 2009** is by **TEXAS FARM PRODUCTS COMPANY**, a Texas corporation, **f/k/a TEXAS FARM PRODUCTS HOLDING COMPANY** ("*Debtor*"), with its principal office and mailing address at 915 S. Fredonia St., Nacogdoches (Nacogdoches County), TX 75964, in favor of **THE FROST NATIONAL BANK**, a national banking association, doing business as **FROST CAPITAL GROUP**, whose office address is at 2727 N. Harwood, 10th Floor, Dallas (Dallas County), TX 75201 (together with its successors and assigns, "*Secured Party*").

**RECITALS**

WHEREAS, Debtor and Secured Party are parties to (a) that certain **SECURITY AGREEMENT** dated as of even date herewith (as amended, modified or restated from time to time, the "*Security Agreement*"), and (b) that certain **TRADEMARK COLLATERAL SECURITY AGREEMENT** dated as of even date herewith (as amended, modified or restated from time to time, the "*Trademark Security Agreement*" and together with the Security Agreement, collectively, the "*Security Agreements*") pursuant to which, Debtor granted to Secured Party a security interest in all of Debtor's right, title and interest in certain Collateral (as defined in the Trademark Security Agreement) including the Trademark Licenses (as defined in the Trademark Security Agreement"), the Trademarks (as defined in the Trademark Security Agreement) and associated registrations set forth in **SCHEDULE A** attached hereto; and

WHEREAS, it is the purpose of this document to evidence the grant of the security interest in a form suitable for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration received as referenced in the Security Agreements and for other good and valuable consideration, the receipt of which is hereby acknowledged, Debtor grants to Secured Party, subject to and upon the terms of the Security Agreement, a security interest in all of Debtor's right, title and interest in and to the Collateral (as such term is defined in the Trademark Security Agreement) set forth in **SCHEDULE A** attached hereto as collateral security for the prompt payment in full when due (whether at stated maturity, by acceleration or otherwise) of the Indebtedness (as defined in the Security Agreement).
