

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Successor Agent does hereby release any and all security interest it may have or ever have had in and to all trademarks, service marks, trade names, designations, or logos owned by any of the Releasees, including but not limited to (i) trademark registrations or pending trademark applications; and (ii) the trademarks (including registrations or pending applications therefore) listed on the attached Schedule A (all such properties covered by (i) and (ii) collectively referred to as the “Trademarks”).

The Successor Agent releases any and all security interest it may have or may have ever had to the Trademarks including but not limited to by virtue of (i) the Assignment and Assumption Agreement entered into on July 27, 2009 between the Successor Agent and Credit Suisse, as existing Administrative Agent (the “Existing Administrative Agent”) and Collateral Agent (the “Existing Collateral Agent”; together with the Existing Administrative Agent, the “Existing Agent”), recorded with the U.S. Patent and Trademark Office at Reel/Frame numbers 4032/0935, 4033/0045, 4033/0060, and 4032/0973; (ii) the May 31, 2007 Second Lien Pledge and Security Agreement (as amended, supplemented, amended and restated, or otherwise modified from time to time) by and among VSS-AHC Consolidated Holdings Corp., Advanstar Inc., and each subsidiary thereof on the one hand and Existing Agent on the other hand; (iii) the May 31, 2007 Second Lien Credit Agreement by and among Advanstar, Inc. (as successor-in-interest to VSS-AHC Consolidated Holdings Corp.), Advanstar Communications, Inc. (as successor-in-interest to VSS-AHC Acquisition Corp.), the Lenders party thereto from time to time, Credit Suisse Securities (USA) LLC and Barclays Bank PLC, as Joint Lead Arrangers and Book Runners, TD Securities (USA) LLC and The Governor and Company of The Bank of Ireland; as Syndication Agents, BNP Paribas, as Documentation Agent and the Existing Agent and (iv) the May 31, 2007 Trademark Security Agreement by and among VSS-AHC Consolidated Holdings Corp., VSS-AHC Acquisition Corp. (and each subsidiary thereof) on the one hand and the Existing Agent on the other hand, recorded with the U.S. Patent and Trademark Office at Reel/Frame 3732/0595, 3732/0495, 3732/0472. The Successor Agent hereby assigns, without recourse, representation or warranty of any kind, unto Releasees its entire right, title and interest in and to the Trademarks and the registrations or applications therefor.

The Successor Agent will, at the sole cost and expense of the Releasees, execute such Uniform Commercial Code termination statements as Releasees may reasonably request in order to terminate any security interest the Successor Agent may have in and to the Trademarks and to execute such other documents and instruments, and take other such actions (at the expense of Releasees) as Releasees may reasonably request to evidence this termination and release and the release of any security interests in the Trademarks and registrations or applications therefor.


