Sell, assign, transfer and set over to Assignee, the entire worldwide right, title and interest in and to the Trademark, for the United States and for all foreign countries, any and all goodwill symbolized thereby, and any United States and foreign registrations and/or applications thereof, including U.S. Reg. No. 2,867,857;

2. Agree to execute any and all documents, agreements, affidavits or other documents or filings necessary to implement the transfer of all rights, title and interest in and to the Trademark to Assignee as provided in this Assignment;

3. Covenant and agree that this Assignment and all of the terms hereof shall inure to the benefit of the successors, assigns, legal representatives, or nominees of Assignee, without further written or oral authorization from Assignors and that this Assignment and all of the terms hereof are binding on Assignors' successors, assigns, legal representatives or nominees.






