## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "*Assignment*"), dated as of October 26, 2009 (the "*Effective Date*"), is made by and among Sun-Times Media Group, Inc., a Delaware corporation ("*Seller*"), the Seller Subsidiaries listed on the signature pages hereto (collectively, the "*Seller Subsidiaries*") (Seller and Seller Subsidiaries are collectively referred to herein as "*Assignors*"), and Sun-Times Media IP, LLC, an Illinois limited liability company ("*Assignee*"). All capitalized terms used but not otherwise defined herein have the meanings set forth in that certain Asset Purchase Agreement, dated as of September 8, 2009, by and among Seller, Sun-Times Media Holdings, LLC (f/k/a STMG Holdings, LLC) ("*Buyer*") and the other parties listed on the signature pages thereto (as may be amended, supplemented or otherwise modified from time to time, the "*APA*").

WHEREAS, Assignee is a Buyer Designee and pursuant to the APA, Assignors wish to assign to Assignee, and Assignee wishes to acquire from Assignors, the trademark registrations and applications set forth on Annex I attached hereto together with the goodwill associated therewith (collectively, the "*Marks*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby sell, assign, transfer and set over to Assignee their entire right, title and interest in and to the Marks, for the United States and for all foreign countries, including, without limitation, all corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims in law or equity by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect damages for the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignors hereby authorize and request the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.
