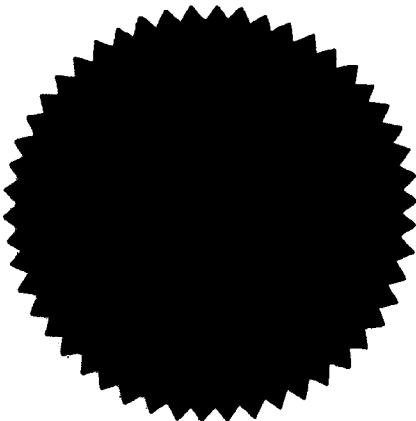

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
LEER REFRIGERATION, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to the provisions of Section 490.1003 and 490.1006 of the Iowa Business Corporation Act, Code of Iowa, as amended, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I. The name of the Corporation is Leer Refrigeration, Inc. The effective date of its incorporation was January 2, 2008.

II. The following amendment to the Articles of Incorporation was recommended to the Shareholder by the Directors and adopted by the Shareholder of the Corporation on January 28, 2008, and was duly approved by the Shareholder in the manner required by this chapter and by the Articles of Incorporation:

Article I is deleted in its entirety and replaced with the following:

"The name of the Corporation is Leer, Inc."

III. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

IV. The Amendment shall become effective on the date of filing with the Secretary of State.
