## TERMINATION AND RELEASE OF SECURITY INTEREST

**This Termination and Release of Security Interest**, dated as of October 27, 2009 ("Termination and Release") is made by Lighthouse Capital Partners V, L.P., ("Secured Party"), in favor of Servigistics SNS, Inc., a Delaware corporation, f/k/a Servigistics, Inc. ("Debtor").

### W I T N E S S E T H :

W H E R E A S , Pursuant to that certain Collateral Assignment, Patent Mortgage and Security Agreement dated as of December 8, 2006 (the "Security Agreement"), Debtor granted a security interest in and lien on, and collaterally assigned to Secured Party an interest in the Collateral (as defined in the Security Agreement) which included U.S. Trademarks (1) Servigistics, having Registration Number 3135200 and (2) Servigistics and Design, having Registration Number 3135202 (the "Trademarks"), any and all trade secrets, any and all design rights, all patents, patent applications and like protections, any other trademarks, any servicemark rights, any and all claims for damages by way of past present and future infringement of any of the listed rights of Debtor, in favor of Secured Party, in favor of Secured Party; and

W H E R E A S , Secured Party has agreed to terminate and release its security interest and all of its right, title and interest in the Collateral as herein provided;

N O W , T H E R E F O R E , in consideration of the premises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby agrees with Debtor as follows:



Secured Party hereby terminates and releases any and all right, title and interest to its security interest in and to the Collateral, including the Trademarks and any proceeds that may result from the Trademarks, and reassigns any and all interest it may have in such Collateral to Debtor, effective as of the date set forth above.

2. Debtor hereby acknowledges and accepts the foregoing release and assignment by Secured Party.
