RECKITT & COLMAN INC., a Delaware corporation, pursuant to the provisions of Section 251 of the General Corporation Law of the State of Delaware, hereby certifies that:

1. The name and state of incorporation of each of the constituent corporations are:

- (a) Reckitt & Colman Inc., a Delaware corporation;
- (b) Benckiser Consumer Products Inc., a Delaware corporation; and
- (c) RCN Products, Inc., a Delaware corporation.

2. An Agreement of Merger (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations, in accordance with the provisions of subsection (c) of Section 251 of the General Corporation Law of the State of Delaware.
