TRADE RIGHTS ASSIGNMENT

WHEREAS, Fiskars Brands, Inc., a Wisconsin corporation (“ASSIGNOR”) is the current owner of the trademark registrations/applications, domain names and all associated rights listed on the attached Schedule A (the “Trade Rights”); and

WHEREAS, Colorbök Inc., a Michigan corporation (“ASSIGNEE”) wishes to acquire the Trade Rights together with the goodwill of the business in connection with which the Trade Rights are used;


WHEREAS, ASSIGNOR desires to retain certain rights to use the Trade Rights in its business as provided in Section 4 of that certain License Agreement dated July 14, 2009, between ASSIGNOR and ASSIGNEE (the “Retained Rights”); and

WHEREAS, ASSIGNOR and ASSIGNEE have executed an agreement through which the business of the ASSIGNOR to which the Trade Rights pertain has been previously assigned to ASSIGNEE.

NOW, THEREFORE, in consideration of and in exchange for one dollar (\$1.00) and other valuable and legally sufficient consideration, the receipt of which Assignor hereby acknowledges, ASSIGNOR hereby agrees to and does sell, assign and transfer to ASSIGNEE its entire right, title and interest (other than the Retained Rights) in and to the Trade Rights together with the goodwill of the business to which the Trade Rights pertain, as well as all rights of enforcement and recovery for past infringement. ASSIGNOR further agrees to take all reasonable and necessary steps to implement the provisions of this assignment. The foregoing assignment is subject to ASSIGNOR’s Retained Rights in the Trade Rights.
