**RELEASE AND TERMINATION  
OF  
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement, dated December 20, 2005 (the "Trademark Security Agreement"), was executed by Waterford Crystal Limited, a corporation registered in Ireland with company number 78088, with a principal place of business at County Waterford, Ireland (the "Grantor"), covering the trademarks more fully described on Exhibit A annexed hereto and made a part hereof in favor of Bank of America, N.A, a national association with a principal place of business at 335 Madison Avenue, New York, NY 10017 (the "Secured Party") and recorded with the United States Patent and Trademark Office on Reel 3263, Frame 0501. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Grantor has requested and the Secured Party has agreed to release the Trademark Collateral and discharge the Trademark Security Agreement.


For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, cancels and releases any and all security interests and liens it has against the Trademark Collateral, including all right, title and interest in the Trademark Collateral which were pledged, mortgaged and set over or otherwise made subject to a lien to the Secured Party by Grantor pursuant to the Trademark Security Agreement and terminates the Trademark Security Agreement.

This agreement shall be governed by and construed and enforced in accordance with the internal laws (as opposed to conflicts of law provisions) of the State of New York.
