ARTICLES OF AMENDMENT

FUTUREHEALTH HOLDING COMPANY

FutureHealth Holding Company (the "Company"), a Maryland corporation, having its principal office in city of Hunt Valley, Baltimore County, Maryland, certifies to the State Department of Assessments and Taxation of Maryland (the "Department"):

The charter is hereby amended by striking in its entirety Article Second, which states the name of the corporation shall be "FutureHealth Holding Company," and in lieu thereof the following Article Second shall be inserted:

Article Second: The name of the corporation shall be
"Nationwide Better Health, Inc."

The charter is hereby amended by striking in its entirety Article Fourth, which list the post office address of the principal office of the Corporation and add in lieu thereof the following Article Fourth shall be inserted:
