SHORT-FORM INTELLECTUAL PROPERTY  
SECURITY AGREEMENT

WHEREAS, each signatory (each an “Obligor”) to this Short-Form Intellectual Property Security Agreement (“this Agreement”) is the owner of the trademarks and the registrations and pending applications associated therewith listed under its respective name on Schedule I attached hereto;

WHEREAS, each Obligor has contemporaneously with the execution of this Agreement entered into the Third Amended and Restated Security Agreement dated as of October 29, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”; and terms defined in the Security Agreement and not otherwise defined herein being used herein as defined therein) among Sinclair Television Group, Inc., as borrower, the other Obligors party thereto (including each Obligor party to this Agreement) and JPMorgan Chase Bank, N.A., as administrative agent (the “Administrative Agent”), pursuant to which each Obligor has granted certain security interests in favor of the Administrative Agent; and

WHEREAS, pursuant to the Security Agreement, each Obligor has agreed with the Administrative Agent to execute this Agreement;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Obligor hereby grants to the Administrative Agent for the benefit of the Secured Parties (as such term is defined in the Credit Agreement), according to the terms of the Security Agreement, a security interest in all of its right, title and interest in, to and under all the Trademark Collateral of such Obligor located in the United States of America, together with, among other things, the good-will of the business symbolized by the trademarks, including its respective trademarks listed on Schedule I attached hereto, and all registrations and pending applications associated therewith, as collateral security for the payment in full when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations.




