TRADEMARK ASSIGNMENT

WHEREAS, Nestor, Inc. and Nestor Traffic Systems, Inc., Delaware corporations (each individually and collectively referred to herein as "Nestor") is the owner of record of the U.S. Trademark Application No. 78/925054 for the mark VIDAR (the Mark); and Jonathan N. Savage, the Court-appointed Permanent Receiver (the "Receiver") of Nestor and the Receivership Estate, in accordance with the Orders entered by the Rhode Island Superior Court in the consolidated receivership proceeding docketed as *MICHAEL JAMES, Chief Executive Officer v. Nestor, Inc.*, C.A. No. 09-3152 and *MICHAEL JAMES, President v. Nestor Traffic Systems, Inc.*, C.A. No. 09-3153 (the "Receivership Proceeding") have taken and are vested with the title to the Mark; and

WHEREAS, The Receiver has been appointed as the Permanent Receiver for the Receivership Estate of Nestor, by order of the Rhode Island Superior Court sitting in Providence County in the Receivership Proceeding;

WHEREAS, On or about September 8, 2009, the Rhode Island Superior Court sitting in Providence County entered an Order approving the Receiver's Petition to Sell Assets to American Traffic Solutions, Inc., a Kansas corporation having a place of business address at 7681 E. Gray Rd., Scottsdale, Arizona 85260;


WHEREAS, On or about September 10, 2009, the Receiver and American Traffic Solutions, Inc. closed the Court-authorized sale and the Receiver sold, transferred and/or assigned any and all right, title and interest to the Mark, among other assets, to American Traffic Solutions, Inc.

WHEREAS, As a result of the Court-authorized Receiver's sale, American Traffic Solutions, Inc., is the holder of all right, title and interest to which the Mark pertains;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Court-appointed Permanent Receiver for Nestor Traffic Systems, Inc. does hereby assign and confirm the assignment unto American Traffic Solutions, Inc. all right, title, and interest in and to the Mark in the United States and foreign countries, the business to which the Mark pertains, the goodwill of the business symbolized by the Mark, the application, and any Registrations therefor, and the right to recover for past infringement.
