ASSIGNMENT OF CERTAIN TRADEMARKS

NOW THEREFORE, be it known that for the consideration described above, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells and assigns to Assignee all of Assignor's right, title and interest in the United States in and to said Trademarks, together with any goodwill of the business symbolized by said Trademarks, any future registrations of said Trademarks, all common law rights associated with said Trademarks, all causes of action and other rights that may be asserted under said Trademarks, the right to sue third parties for infringement of or improper activities regarding said Trademarks, and the right to enjoy all of the monetary benefits obtained as a result of any such litigation, the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
