ASSIGNMENT OF TRADEMARK RIGHTS IN EASTERN TERRITORY



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all right, title, and interest, including any associated goodwill in and to that portion of the Mark covering only "restaurant services" in only the geographic region consisting of all of the states of the continental United States of America that are located east of the Mississippi River (the "Eastern Territory"), together with the goodwill of the business symbolized by the Mark in said Eastern Territory.
