
RE: CORRECTION IN THE NATURE OF CONVEYANCE

On June 1, 2007 an assignment of security interest agreement was recorded with the Assignment Services Division. This agreement was incorrectly classified on the cover sheet as assigning the entire right and interest of the registration instead of correctly indicating it was an assignment of a security interest only. This was recorded a Reel 003553 Frame 0334

On October 17, 2007 a corrective assignment was recorded to try to correct the error, however, the corrective assignment still indicated that an entire right and interest was conveyed. This was filed at Reel 003641 Frame 0412

A corrective assignment has been filed on November 6, 2009 correcting both the June 1, 2007 recording and October 17, 2007 recording.

The ownership of the mark actually never changed on June 1, 2008. The last owners remains and continues to be Hoffco/Comet Industries, Inc. located at 358 Northwest F Street, Richmond, IN 47374 remains and is the true and correct owner of registration no. 1601892 COMET.
