ASSIGNMENT OF TRADE MARKS

Assignment of trade marks dated August 28, 2009, between Atlantic Packaging Products Ltd., a corporation organized under the laws of Ontario, (the "Assignor") and Cascades Canada Inc., a corporation organized under the laws of Canada, (the "Assignee").

RECITALS:

- (a) Pursuant to the purchase and sale agreement between the Assignor and the Assignee dated June 11, 2009, as amended and restated by an amended and restated purchase and sale agreement dated August 28, 2009 (the "Purchase Agreement") the Assignor has agreed to sell to the Assignee certain of its undertaking, property and assets, as more particularly described in the Purchase Agreement; and
- (b) The Assignor has agreed to assign to the Assignee all its right, title and interest in and to the Trade Marks (as hereinafter defined).

In consideration of the foregoing and the mutual agreements contained herein (the receipt and adequacy of which are acknowledged), the parties agree as follows:

Section 1 Assignment.

The Assignor sells, assigns, transfers and sets over to the Assignee all of the Assignor's right, title and interest in and to the trade marks, which are registered or for which registration is applied for in the United States Patent and Trademark Office, as set forth in Schedule "A" (collectively, the "Trade Marks"), together with all benefits of the registrations or applications for registration and all right, title and interest in and to any renewals and extensions that may be granted, and together also with all goodwill arising from all use of the Trade Marks before and after registration and any other benefit to be derived therefrom.

Section 2 Registration.

The Assignor consents to an application to the United States Patent and Trademark Office for recognition and recordal of this transfer.

Section 3 Further Assurances.

The Assignor covenants with the Assignee that it will, from time to time, make, do and execute or cause to be made, done and executed all such further acts, deeds, assurances or things as may reasonably be required by the Assignee for more effectually and completely implementing or carrying out this assignment or for the purpose of registration or otherwise.

Section 4 Successors and Assigns.

This assignment shall enure to the benefit of the Assignee and its successors and assigns and shall be binding upon the Assignor and its successors and assigns.

Section 5 Governing Law.

This assignment shall be governed by and interpreted and enforced in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

Section 6 Undertakings.

The Assignor undertakes to use commercially reasonable efforts to provide the Assignee with the original certified copies of the certificates of registration for the Trade-marks that the Assignor has in its possession.


Section 7 Counterparts.


