1. That the name of this corporation is eCredit.com, Inc., and that this corporation was originally incorporated pursuant to the General Corporation Law on September 14, 1993 under the name of SR Research, Inc.

2. That the Board of Directors of the Corporation duly adopted resolutions by written consent, in accordance with Sections 141(f) and 242 of the General Corporation Law, setting forth an amendment to the Amended and Restated Certificate of Incorporation of the Corporation and declaring such amendment to be advisable; and that the stockholders of the Corporation duly approved said proposed amendment by written consent, in accordance with Sections 228 and 242 of the General Corporation Law, as follows:
