RELEASE OF SECURITY AGREEMENT

This Release of Security Agreement (this "Release") is made and entered into as of November 2, 2009, by and between DK Acquisition Partners, L.P., a New York limited partnership, located at 65 East 55th Street, 16th Floor, c/o Davidson Kempner Capital Management, New York, New York 10022 as Agent ("Agent"), and Zappos.com, Inc., a California corporation, located at 2280 Corporate Circle, Suite 100, Henderson, Nevada 89074 (the "Debtor").

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Patent and Trademark Security Agreement dated June 30, 2006 (the "Security Agreement"). The Security Agreement was recorded in the United States Patent and Trademark Office dated as of July 7, 2006 at Reel 3343/Frame 0510 against the intellectual property attached hereto as Exhibit A (the "Intellectual Property"); and

WHEREAS, Debtor has requested that the Agent release, and the Agent is willing to release, subject to the terms hereof, its security interest, and claims of security interest, in the Intellectual Property covered by the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Agent does hereby terminate and release any and all security interests that it may have in, or all claims that it may have to the Intellectual Property, whether now owned or hereafter acquired or created, pursuant to the Security Agreement, without any representation, warranty, or recourse of any kind or nature (other than as expressly set forth in paragraph 3 below).
2. Agent agrees to take such further action as may be reasonably requested by Debtor, from time to time, at Debtor's expense, to effectuate and carry out the provision and intent of this Release.
3. Agent represents and warrants to Debtor that it has not conveyed, transferred, granted a security interest in, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to the Intellectual Property under the Security Agreement to any party other than Debtor.

IN WITNESS WHEREOF, the undersigned has caused this Release of Security Agreement to be executed and delivered as of the date first written above.
