## ASSIGNMENT OF UNITED STATES REGISTERED TRADEMARKS

WHEREAS, COOPER TECHNOLOGIES COMPANY, a Delaware corporation (hereinafter referred to as “ASSIGNEE”), having its principal offices at 600 Travis, Suite 5600, Houston, Texas 77002, is desirous of acquiring all right, title, and interest in and to the Trademarks, including any causes in action relating to said Trademarks, together with the goodwill of the business symbolized by the Trademark registrations.

NOW THEREFORE, in consideration of the sum of \$10.00 USD, the full receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and conveys unto ASSIGNEE all of its right, title, and interest, in and to the aforesaid Trademarks, including any causes in action relating to said Trademarks, claims for damages, profits and costs, both in equity and law, for any infringement or infringements of said Trademarks rights accruing on or before the date of this Assignment, together with the goodwill of the business symbolized by the Trademarks, and including the registrations thereof as indicated above, and further hereby covenants, agrees and undertakes to execute, whenever requested by ASSIGNEE, all applications, assignments, lawful oaths and any other papers which ASSIGNEE may deem necessary or desirable for securing to ASSIGNEE or for maintaining for ASSIGNEE the Trademarks hereby assigned, all without further compensation to ASSIGNOR.


ASSIGNEE hereby accepts the sale, assignment, transfer and conveyance of the Trademarks and the associated goodwill.


ASSIGNOR retains no ownership rights in the Trademarks transferred to ASSIGNEE by this assignment.
