# Confirmatory Assignment of Trademarks

This Confirmatory Assignment of Trademarks ("Assignment") is made effective as of this \_\_\_ day of September, 2009, by and between Axis Dental Corporation, a Texas corporation located at 800 West Sandy Lake Road, Suite 100, Coppell, Texas 75019 ("Assignor") and NTI-Kahla GmbH, a Germany company located at Im Camisch 3, D-07768 Kahla, Germany/Deutschland ("Assignee").

Whereas, Assignor is the owner of the trademarks and registrations listed in the attached Schedule A (the "Trademarks"), and the goodwill of the business symbolized by said Trademarks;

Whereas, Assignor and Assignee entered to an Exclusive Distribution Agreement dated as of June 18, 1998 (the "Distribution Agreement"), wherein Assignee granted exclusive distribution rights to the Trademarks to Assignor;

Whereas, Section 3 "Ownership of Trademarks" of the Distribution Agreement states that should a company acquire Assignor, and has substantially the same products as Assignee, and intends to market its products under the "NTI" name, then the ownership and rights to the Trademarks shall revert back to Assignee;

Whereas, Kerr Corporation, a Delaware corporation ("Kerr"), Assignor, AD Holdings General Partnership, a Texas general partnership ("Seller"), and Henry Schein, Inc. a Delaware corporation and the ultimate parent company of Seller, entered into a certain Stock Purchase Agreement dated August 5, 2009 whereby Kerr acquired ownership of Assignor;

Whereas, Kerr has substantially the same products as Assignee and Kerr intends—to market its products under the "NTI" name;

Whereas, Assignee wishes to terminate said Distribution Agreement and have the ownership and rights over the Trademarks, and the goodwill of the business symbolized by said Trademarks, revert back to Assignee; and

Whereas, Assignee intends to grant Assignor a non-transferable license, for the temporary use of the Trademarks, and the goodwill of the business symbolized by said Trademarks, from August 5, 2009 through December 31, 2010.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged:

- Assignor hereby sells, assigns, and transfer unto the Assignee, Assignor's entire right, title and interest in and to said Trademarks, and Assignor's entire right, title, and interest in and to any and all claims and demands it may have, at law, or in equity, for past infringement of said Trademarks.
- 2. Assignee hereby grants unto Assignor a non-transferable license, for the temporary use of the Trademarks, and the goodwill of the business symbolized by said Trademarks, from the August 5, 2009 through December 31, 2010.
- 3. This Assignment shall be governed by, and construed in accordance with, the laws of the State of California.
- 4. This Assignment contains the entire agreement and understanding between the parties with respect to the subject matter hereof, and merges all prior discussions, representations and negotiations with respect to the subject matter of this Assignment.


