
NOTICE OF LIEN

Fish & Richardson P.C. has not been compensated for certain patent prosecution services and disbursements made for the benefit of Zeemote, Inc. (formally Zeetoo and Zietoo). As of November 3, 2009, the uncompensated amount totaled \$73,848.01 for the patent prosecution services and additional \$36,589.29 for trademark prosecution services. Massachusetts Lawyers Weekly, Ropes & Gray LLP v. Jalbert, SJC-10333 (August 3, 2009).
