**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST, dated as of November 9, 2009, is by GE Business Financial Services Inc. (formerly known as Merrill Lynch Business Financial Services Inc.) (the “Secured Party”), as administrative agent for the lenders party to that certain Credit Agreement dated as of December 6, 2004 with the Company (as defined below).
