BILL OF SALE

THIS BILL OF SALE (this "Bill of Sale") is entered into as of November 2, 2009 by and among NACT Telecommunications, Inc., a Delaware corporation ("NACT"), KaSa Enterprises, Inc., a Florida corporation ("KASA"), and together with NACT, each, a "Seller", and collectively, "Sellers") and LOFM, LLC, a Delaware limited liability company ("Buyer").

Pursuant to that certain Asset Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), by and among Buyer and Sellers, Sellers have agreed to sell to Buyer and Buyer has agreed to purchase from Sellers, for the consideration and upon the terms and conditions set forth in the Purchase Agreement, the Purchased Assets.


NOW, THEREFORE, pursuant to the Purchase Agreement and in consideration of the mutual promises contained therein, and for other good and valuable consideration, the receipt and sufficiency of which Sellers and Buyer each acknowledge, the parties agree as follows:

1. Each capitalized term used but not defined in this Bill of Sale shall have the meaning ascribed to it in the Purchase Agreement.
2. Effective as of the Closing, Sellers hereby sell, convey, assign, transfer, deliver and set over to Buyer all of Sellers' rights in, to and under all of the Purchased Assets free and clear of all Liens other than as set forth in any lease or license pursuant to which any Seller has obtained any such Purchased Asset.
3. Nothing in this Bill of Sale shall be deemed to supersede, enlarge or modify any of the provisions of the Purchase Agreement, all of which survive the execution and delivery of this Bill of Sale as provided and subject to the limitations set forth in the Purchase Agreement. If any conflict exists between the terms of this Bill of Sale and the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern and control.
4. This Bill of Sale is made for the sole benefit of the parties hereto and their respective successors, executors and permitted assigns, and nothing contained herein, express or implied, is intended to or shall confer upon any other Person any third-party beneficiary right or any other legal or equitable rights, benefits or remedies of any nature whatsoever under or by reason of this Bill of Sale.
5. This Bill of Sale shall be effective as of the Closing.
6. This Bill of Sale may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.


