NOW, THEREFORE:



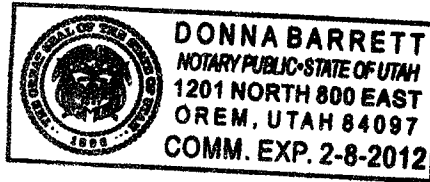
