ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, in consideration of the foregoing, the Parties hereby agree as follows:

1. Assignor hereby sells, transfers, conveys, assigns, and delivers to the Assignee, and the Assignee hereby accepts, all of Assignor's right, title, and interest in and to the following Marks and all registrations of the Marks, together with the goodwill of the business symbolized by the Marks, including, without limitation, any extensions and renewals of the Marks.


