AND FORESTA CO. LTD hereby agrees to execute any papers and to perform such other proper acts as MR. HAYASHI may deem reasonably necessary to secure to MR. HAYASHI, or his successors or assigns, the rights hereby assigned,

TO HAVE AND TO HOLD the same unto MR. HAYASHI, his successors and assigns the Trademark, together with the goodwill of the business associated therewith, effective 16th day of November, 2009.
