TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is entered into effective as of the 13th day of November, 2009 ("Effective Date") by and between ChunChun Lee, a citizen of Taiwan (the "Assignor") and Wilson's Gun Shop, Inc., an Arkansas corporation (the "Assignee").

WHEREAS, Assignor and Assignee wish to resolve a trademark infringement dispute pertaining to the WILSON COMBAT mark; and

WHEREAS, the parties have determined that assignment of the mark is an appropriate solution;

NOW THEREFORE, for and in consideration of these premises and the mutual covenants set forth herein, the parties hereby agree as follows:

Assignor does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of all of Assignor's worldwide right, title and interest in, to and under the Assignor's registered and unregistered domestic and foreign trademarks incorporating the terms "WILSON COMBAT," the components of those marks, both individually and collectively, trademark applications, and all rights in use of the names as trade names and fictitious names, together with the goodwill of the business associated therewith and which is symbolized thereby; in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto; in and to all causes of action (either in law or in equity) and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment of Trademarks, whether arising prior to or subsequent to the Effective Date; and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by the Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment of Trademarks not been made.

Assignor agrees that it will make no further use of any marks incorporating the terms "WILSON COMBAT," or "WILSON" in combination with any other terms, for any purpose.
