

**REQUEST TO CORRECT RECORDATION OF ASSIGNMENT  
ERRONEOUSLY RECORDED AGAINST REGISTRATION NO. 1,559,349  
(FOR THE MARK BLACK DOG) PURSUANT TO 37 C.F.R. § 3.34**

- Due to a typographical error on the Trademark Recordation Cover Sheet at Reel: 1886 Frame: 0353, an assignment was erroneously recorded against Registration No. 1,559,349 (for the mark "BLACK DOG"). Original Trademark Recordation Cover Sheet is attached as Attachment 1.
- When the original Recordation Cover Sheet is compared to the Assignment document to which it pertains (Assignment Document is attached as Attachment 2), it is clear that the assignment should have been recorded against Registration No. 1,599,349 (for the mark CROSSING GUARD) and that Registration No. 1,559,349 (for the mark BLACK DOG) listed on the original Recordation Cover Sheet was the result of a typographical error.

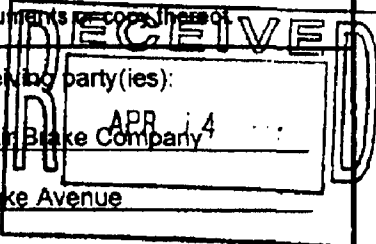
