SHORT-FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT

SHORT-FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 10, 2009, among DELILAH INTERNATIONAL S.À R.L., any Additional Grantors (as defined herein) (each of the foregoing, a "**Grantor**", and collectively, the "**Grantors**"), and THE ROYAL BANK OF SCOTLAND PLC, as Security Agent for the Secured Parties (herein in such capacity, the "**Security Agent**").

RECITALS

- (A) Delilah S.à r.l. (the "**Parent**"), the Borrowers from time to time party thereto (each, a "**Borrower**", and collectively, the "**Borrowers**"), the Guarantors from time to time party thereto, The Royal Bank of Scotland plc as mandated lead arranger, the financial institutions from time to time party thereto, as lenders, and The Royal Bank of Scotland plc as Facility Agent and Security Agent are parties to a senior facilities agreement, dated October 23, 2007, as amended and restated on December 6, 2007 and May 30, 2008, and as further amended and restated pursuant to an amendment and restatement agreement dated September 2, 2009, providing for the making of advances to, and the issuance of, and participation in, letters of credit for the respective accounts of the Borrowers, all as contemplated therein (as used herein, the term "**Senior Facilities Agreement**" means the Senior Facilities Agreement described above in this paragraph, as the same may from time to time be amended, modified, extended, renewed, replaced, restated, supplemented and/or refinanced from time to time, and including any agreement extending the maturity of, or refinancing or restructuring (including, but not limited to, the inclusion of additional borrowers or guarantors thereunder or any increase in the amount borrowed thereunder) of all or any portion of the indebtedness under such agreement or any successor agreement, whether or not with the same agent, trustee, representative, banks or holders).
- (B) The Parent, the Obligors, the Facility Agent, the Security Agent and the other parties thereto have entered into an Intercreditor Agreement, dated as of October 23, 2007, as amended and restated from time to time and as amended and restated pursuant to an amendment and restatement agreement dated September 2, 2009 (as amended, modified, restated and/or supplemented from time to time, the "**Intercreditor Agreement**").
- (C) Grantor is party to an Intellectual Property Security Agreement, dated the date hereof, in favor of the Security Agent (the "**Intellectual Property Security Agreement**"), pursuant to which Grantor is required to execute and deliver this Agreement.
- (D) In consideration of the premises and for other valuable consideration, the receipt and sufficiency of which the parties hereto hereby acknowledge, each of the Grantors and the Security Agent, on behalf of itself and each Secured Party (and each of their respective successors or permitted assigns), hereby agree as follows:

SECTION 1 Defined Terms

Unless otherwise defined herein, terms defined in the Intellectual Property Security Agreement and used herein have the meaning given to them in the Intellectual Property Security Agreement.

SECTION 2 Grants of Security Interests in Intellectual Property Collateral

As security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code) of all Secured Obligations, Grantor hereby pledges,

assigns, transfers and grants to the Security Agent, for its benefit and for the benefit of the Senior Secured Parties, a continuing security interest in and Lien on all of its right, title and interest in, to and under all Intellectual Property Collateral, whether now owned or existing or hereafter acquired or arising.

"Intellectual Property Collateral" means Grantor's right, title and interest in, to and under

- (a) all Copyrights, including those referred to on Schedule I hereto,
- (b) all Patents, including those referred to on Schedule II hereto and
- (c) all Trademarks, including those referred to on Schedule III hereto;
- (d) all goodwill of the business connected with the use of, and symbolized by, each Trademark;
- (e) all Intellectual Property Licenses;
- (f) all reissues, continuations or extensions of the foregoing; and
- (g) all Proceeds of the foregoing, including any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any (x) Copyright, (y) Trademark or (z) Patent or (ii) injury to the goodwill associated with any Trademark.

SECTION 3 Certain Exclusions

Notwithstanding anything herein to the contrary, in no event shall the Collateral include and Grantor shall not be deemed to have granted a Security Interest in, any of its right, title or interest in any Intellectual Property if the grant of such Security Interest shall constitute or result in the abandonment of, invalidation of or rendering unenforceable any of its right, title or interest therein.

SECTION 4 Intellectual Property Security Agreement

The security interests granted pursuant to this Short-Form Intellectual Property Security Agreement are granted in conjunction with the security interests granted to the Security Agent pursuant to the Intellectual Property Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the security interests granted to it in the Collateral made and granted hereby are more fully set forth in the Intellectual Property Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

SECTION 5 Governing Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW.

SHORT-FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT

SHORT-FORM INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 8, 2009, among DELILAH INTERNATIONAL S.À R.L., any Additional Grantors (as defined herein) (each of the foregoing, a "Grantor", and collectively, the "Grantors"), and THE ROYAL BANK OF SCOTLAND PLC, as Security Agent for the Secured Parties (herein in such capacity, the "Security Agent").

RECITALS

- (A) Delilah S.à r.l. (the "Parent"), the Borrowers from time to time party thereto (each, a "Borrower", and collectively, the "Borrowers"), the Guarantors from time to time party thereto, The Royal Bank of Scotland plc as mandated lead arranger, the financial institutions from time to time party thereto, as lenders, and The Royal Bank of Scotland plc as Facility Agent and Security Agent are parties to a senior facilities agreement, dated October 23, 2007, as amended and restated on December 6, 2007 and May 30, 2008, and as further amended and restated pursuant to an amendment and restatement agreement dated September 2, 2009, providing for the making of advances to, and the issuance of, and participation in, letters of credit for the respective accounts of the Borrowers, all as contemplated therein (as used herein, the term "Senior Facilities Agreement" means the Senior Facilities Agreement described above in this paragraph, as the same may from time to time be amended, modified, extended, renewed, replaced, restated, supplemented and/or refinanced from time to time, and including any agreement extending the maturity of, or refinancing or restructuring (including, but not limited to, the inclusion of additional borrowers or guarantors thereunder or any increase in the amount borrowed thereunder) of all or any portion of the indebtedness under such agreement or any successor agreement, whether or not with the same agent, trustee, representative, banks or holders).
- (B) The Parent, the Obligors, the Facility Agent, the Security Agent and the other parties thereto have entered into an Intercreditor Agreement, dated as of October 23, 2007, as amended and restated from time to time and as amended and restated pursuant to an amendment and restatement agreement dated September 2, 2009 (as amended, modified, restated and/or supplemented from time to time, the "Intercreditor Agreement").
- (C) Grantor is party to an Intellectual Property Security Agreement, dated the date hereof, in favor of the Security Agent (the "Intellectual Property Security Agreement"), pursuant to which Grantor is required to execute and deliver this Agreement.
- (D) In consideration of the premises and for other valuable consideration, the receipt and sufficiency of which the parties hereto hereby acknowledge, each of the Grantors and the Security Agent, on behalf of itself and each Secured Party (and each of their respective successors or permitted assigns), hereby agree as follows:

SECTION 1 Defined Terms

Unless otherwise defined herein, terms defined in the Intellectual Property Security Agreement and used herein have the meaning given to them in the Intellectual Property Security Agreement.

SECTION 2 Grants of Security Interests in Intellectual Property Collateral

As security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, including the payment of amounts that would become due but for the operation of the automatic stay under Section 362(a) of the Bankruptcy Code) of all Secured Obligations, Grantor hereby pledges,

assigns, transfers and grants to the Security Agent, for its benefit and for the benefit of the Senior Secured Parties, a continuing security interest in and Lien on all of its right, title and interest in, to and under all Intellectual Property Collateral, whether now owned or existing or hereafter acquired or arising.

"Intellectual Property Collateral" means Grantor's right, title and interest in, to and under

- (a) all Copyrights, including those referred to on Schedule I hereto,
- (b) all Patents, including those referred to on Schedule II hereto and
- (c) all Trademarks, including those referred to on Schedule III hereto;
- (d) all goodwill of the business connected with the use of, and symbolized by, each Trademark;
- (e) all Intellectual Property Licenses;
- (f) all reissues, continuations or extensions of the foregoing; and
- (g) all Proceeds of the foregoing, including any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any (x) Copyright, (y) Trademark or (z) Patent or (ii) injury to the goodwill associated with any Trademark.

SECTION 3 Certain Exclusions

Notwithstanding anything herein to the contrary, in no event shall the Collateral include and Grantor shall not be deemed to have granted a Security Interest in, any of its right, title or interest in any Intellectual Property if the grant of such Security Interest shall constitute or result in the abandonment of, invalidation of or rendering unenforceable any of its right, title or interest therein.

SECTION 4 Intellectual Property Security Agreement

The security interests granted pursuant to this Short-Form Intellectual Property Security Agreement are granted in conjunction with the security interests granted to the Security Agent pursuant to the Intellectual Property Security Agreement and Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the security interests granted to it in the Collateral made and granted hereby are more fully set forth in the Intellectual Property Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

SECTION 5 Governing Law

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW.
