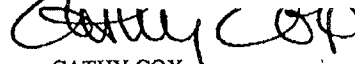

Pursuant to the provisions of Section 14-11-904 of the Georgia Limited Liability Company Act (the "Act") and Section 14-2-1105 of the Georgia Business Corporation Code (the "Code"), the undersigned corporation files this Certificate of Merger.

1. The name and jurisdiction of incorporation or organization of each party to the merger are as follows:

- a. PlayMotion Phoenix, Inc., a Georgia corporation.
- b. PlayMotion LLC, a Georgia limited liability company.

2. The surviving entity into which the other entity will be merged is PlayMotion Phoenix, Inc., a Georgia corporation (the "Surviving Entity").

7. A copy of the plan of merger will be furnished by the Surviving Entity, on request and without cost, to any member of PlayMotion LLC, or any shareholder of PlayMotion Phoenix, Inc.

8. The Surviving Entity hereby undertakes to request for publication a notice of filing of this Certificate of Merger and make payment therefore, as required by Section 14-2-1105.1 of the Code.
