
1. They are the President and Secretary, respectively, of VXI Technology, Inc., a California corporation.
2. Article ONE of the Articles of Incorporation of this corporation is amended to read as follows:


"ONE: The name of this corporation is VTI INSTRUMENTS CORPORATION."
