RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of October 27, 2009, is made by BANK OF AMERICA, N.A., as successor by merger to LaSalle Business Credit, LLC, as agent ("Agent"), under the Loan and Security Agreement referred to below (capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Loan and Security Agreement).

WHEREAS, the Patent and Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on August 11, 2006 at Reel/Frame No. 018109/0114 and at Reel/Frame No. 3369/0360; and

WHEREAS, Grantors wish to confirm the release of any and all interest Agent may have in the Released Trademarks for the purpose of Grantors selling, assigning or granting security interests in and to such Released Trademarks and for recording such release with the U.S. Patent and Trademark Office.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks and any other Patent Collateral and Trademark Collateral (as such terms are defined in the Patent and Trademark Security Agreement).
