TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 18, 2009, by ABLECO FINANCE LLC, a Delaware limited liability company ("Ableco"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

W I T N E S S E T H:

WHEREAS, YOGURT HOLDINGS II, INC., a Delaware corporation, THE YOFARM COMPANY, a Delaware corporation, NORTH LAWRENCE DAIRY, INC. (formerly Coolbrands Dairy, Inc.), a Delaware corporation, (each a "Grantor" and collectively the "Grantors") and Ableco were parties to a Trademark Security Agreement dated as of January 30, 2007 (the "Assignment"), pursuant to which Grantors granted a security interest to Ableco, as Collateral Agent for the benefit of the Lender Group, in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantors to the Lender Group, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on January 31, 2007, at Reel 3471, Frame 0852; and

WHEREAS, Grantors have requested that Ableco release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Ableco hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claims by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Ableco hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Ableco, all of Ableco's right, title and interest in and to the Trademarks and the Trademark Rights.
