Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.

Assignor and Assignee hereby agree that this Assignment will be governed by and construed in accordance with the laws of the State of New York, without regard to rules of conflicts of law.

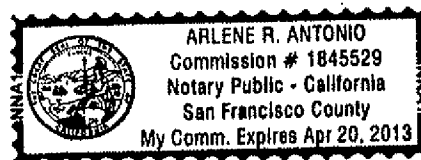


