TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 5, 2009 (the "Termination and Release"), from Credit Suisse, Sydney Branch, having a principal place of business at Level 41, 101 Collins Street, Melbourne, Victoria 3000, Australia, as facility agent and security trustee (the "Security Trustee") for itself and certain banks and financial institutions (the "Lenders") that are parties to the Facilities Agreement (as defined below), to Reynolds Consumer Products, Inc., a Delaware corporation having a principal place of business at 6603 West Broad Street, Richmond, Virginia, 23230 (the "Grantor"). Capitalized terms used herein without definition are used as defined in the Senior Secured Facilities Agreement, dated as of February 21, 2008, among the Reynolds Packaging Group (NZ) Limited, the Grantor, Reynolds Consumer Products Holdings Inc., Closure Systems International B.V., Reynolds Treasure (NZ) Limited, the Joint Lead Arrangers and Underwriters, the Security Trustee and the Lenders (as amended, supplemented or otherwise modified from time to time, the "Facilities Agreement") or the Collateral Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the U.S. Collateral Agreement, dated as of February 29, 2008 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), made by the Grantor and the other Grantors (as defined therein) in favor of the Security Trustee, a security interest (the "Security Interest") was granted by the Grantor to the Security Trustee in certain Trademarks;

WHEREAS, in connection with the Collateral Agreement, the parties entered into a Notice and Confirmation of Grant of Security Interest in Trademarks effective February 29, 2008, which was recorded in the Trademark Division of the United States Patent and Trademark Office on April 10, 2008, at Reel 003756, Frame 0857; and

WHEREAS, the Security Trustee now desires to terminate and release the entirety of its Security Interest in the Trademarks (as defined below).

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Security Trustee hereby states as follows:

1. Trademarks. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest in or to all of the Trademarks, whether owned by the

Grantor as of the date of the Collateral Agreement or acquired by the Grantor thereafter, but prior to the date hereof, including those listed on Schedule I.

2. Release of Security Interest. The Security Trustee hereby unconditionally and irrevocably terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Security Trustee in such Trademarks shall hereby cease and become void.

3. Further Assurances. The Security Trustee shall execute and deliver to the Grantor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the Security Interest.


