RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of November 19, 2009 by SUNTRUST BANK, as Agent for the Lenders ("**Secured Party**").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 28, 2007 (the "**Security Agreement**"), by and between Transaction Network Services, Inc., a Delaware corporation (the "**Grantor**") and General Electric Capital Corporation, as initial agent (the "**Initial Agent**"), the Grantor granted a security interest to the Initial Agent in certain Trademark Collateral (as defined in the Security Agreement), including the Trademarks set forth on Schedule I thereto; and

WHEREAS, the Security Agreement was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on April 25, 2007 at Reel 3538, Frame 0952;

WHEREAS, the Initial Agent assigned all of its rights, powers and privileges as Agent under the Credit Agreement (as such term is defined in the Security Agreement) and the Trademark Security Agreement to the Secured Party, pursuant to that certain Assignment of Security Interest in Trademarks under the Trademark Security Agreement, dated as of May 1, 2009 (the "**Assignment**"), by and between the Initial Agent and the Secured Party;

WHEREAS, the Assignment was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on May 5, 2009 at Reel 003982, Frame 0329; and

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Trademark Collateral and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.
