**NOTICE OF RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

WHEREAS, pursuant to that Third Trademarks Security Agreement dated as of May 14, 2003, (hereinafter referred to as the "Security Agreement"), executed by and between **ALTEC LANSING TECHNOLOGIES, INC.**, a Pennsylvania corporation, predecessor-in-interest by merger to **PLANTRONICS, INC.**, a Delaware corporation, with an address of 345 Encinal Street, Santa Cruz, California 95060 (hereinafter referred to as the "Borrower", as such term is defined in the Security Agreement), in favor of WACHOVIA BANK, NATIONAL ASSOCIATION, A NATIONAL BANKING ASSOCIATION, SUCCESSOR TO MERGER TO **CONGRESS FINANCIAL CORPORATION**, with an address of 1133 Avenue of the Americas, New York, New York 10036 (hereinafter referred to as the "Lender", as such term defined in the Security Agreement), the Lender made available to the Borrower various loans that were secured by the Secured Agreement.

WHEREAS, the Security Agreement was recorded at the U.S. Patent and Trademark Office on June 27, 2003 starting at Reel/Frame 2765/0116; and


WHEREAS, to secure payment and performance of all of the obligations of the Borrower to the Lender, the Borrower mortgaged to and pledged to the Lender, and granted to and conveyed to the Lender a security interest in all of Borrower's rights, title and interests in and to certain "Assets" (as such term is defined in the Security Agreement), including but not limited to certain trademark properties, identified in Appendix A attached hereto.

It is now hereby confirmed that, by and between the Lender and the Borrower, all Obligations set forth in the Security Agreement have been satisfied by the Borrower, the Lender has been paid off in full, and all security interests granted in the Security Agreement have been released.

This Notice of Release of Security Interest in Intellectual Property is being prepared for recordation purposes with the U.S. Patent and Trademark Office to be recorded against the certain trademark properties, identified in Appendix A attached hereto.
